ORDER

The order dated 18.1.2012 of the Joint Commissioner, Sivagangai passed in OA 20/1997 is hereby confirmed and the appeal petition is dismissed as devoid of merits. However, it is inferred from the

documents that the management of the suit temple has been vested with the family of the Appellant. Hence, it is open to them to file an application under Section 63 (b) of the Act before the competent authority to declare the office of the trusteeship as hereditary one.
